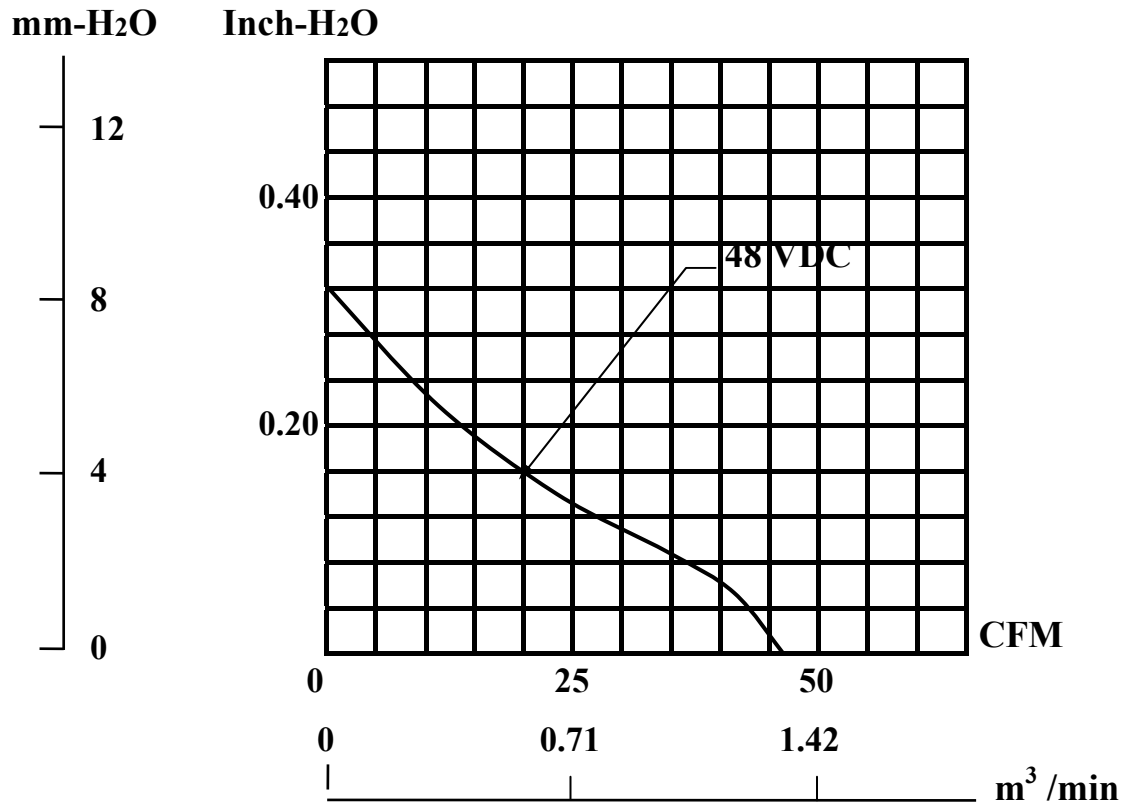

PRESSURE**

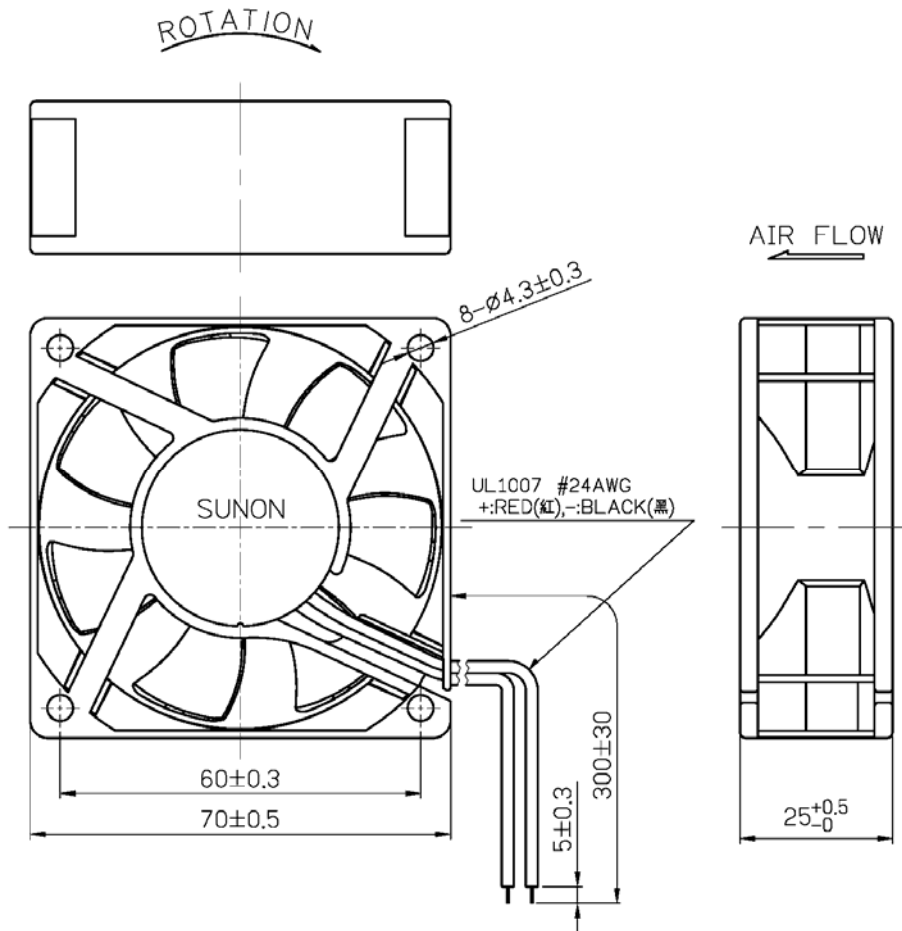
